PTO Board Meeting Minutes - Fundraising Meeting  
February 28, 2010 at 2:00pm

Meeting called to order at 2:13.

**Fun Fair/Health Fair** – Bette requested that the Fun Fair be combined with the OCWC Health Fair. The OCWC is scheduled to host a County wide Health Fair with the LOW Lion's Club on May 15<sup>th</sup>, but due to political and organizational issues with the OCWC being established, the OCWC is not able to have the event.
